### Ministry of Energy

#### Mission

Federal Executive Department responsible for conducting the energy policy of the country within the prevailing constitutional framework, with aims at ensuring competitive, sufficient, high quality, affordable and environmentally sustainable supply of energy resources, as required by the development of national life.

#### Functions

- To establish, conduct and coordinate energy policy.
- To select, with the assistance of CNH, hydrocarbon exploration and extraction areas that may be subject to contract.
- To establish the technical design of contracts and guidelines that must be observed during the bidding process.
- To design contracts and terms under which bidding processes take place.
- To establish the contract model to be used in each bidding round (production, shared utility or license).



### Ministry of Finance and Public Credit

#### Mission

Federal Executive Department responsible for recommending, conducting and controlling the economy policy of the Federal Government regarding finance, taxes, revenue, and public debt, thus aiming to strengthen a country with quality economic growth.

#### Functions

- To establish economic conditions, concerning tax terms, for bidding processes and contracts.
- To state an opinion on the contracting model to be used in each bidding round.
- To establish the awarding variables of bidding processes.

### **National Hydrocarbons Commission**

#### **Mission**

Coordinated Energy Regulatory Body, branching from the Federal Executive, with legal personality of its own, as well as technical, operational and management autonomy, responsible for efficiently and reliably regulating hydrocarbon exploration and extraction in Mexico, to favor investment and economic growth.

#### **Functions**

- To perform bidding processes and to award contracts to winners.
- To execute contracts on behalf of the State.
- To provide technical administration for contracts.
- To authorize well drilling.
- To regulate and supervise hydrocarbon exploration and extraction, including collection from the point of production up to integration to the transportation and storage system.



### **Mexican Petroleum Fund**

#### **Mission**

Public Trust of the State, constituted by the Ministry of Tax and Public Credit as trustor, and the Bank of Mexico, trust institution in charge of receiving, managing and distributing the oil revenue of the State in a responsible and transparent manner, thus facilitating accountability, and contributing to the stabilization and development of the Nation, for the benefit of Mexicans of all generations.

#### **Functions**

- To receive, manage and distribute the revenue of the State deriving from hydrocarbon exploration and extraction.
- To transfer resources both to several stabilization and sector funds and to the federal budget each year (up to 4.7% of GDP).
- To invest the long- term savings reserve with aims at contributing to the development to the country and benefiting future generations.



## **National Agency for Industrial Safety and Environmental Protection**

### **Mission**

Decentralized administrative body of the Ministry of Environment and Natural Resources with technical and management autonomy, responsible for ensuring safety of people and environmental integrity in the hydrocarbon sector with legal, procedural and cost-related certainty.

### **Functions**

- To regulate and supervise facilities and activities in the hydrocarbon sector in terms of industrial, operational and protection safety, including facility dismantling and abandonment, as well as waste control.
